**Course Description:** EDUC 42D3 is an introduction to teacher education. Pre-service teachers engage in reflective practice to consider their own identity, integrity, and professionalism as they explore the art and science of teaching. Topics include an introduction to curriculum frameworks, integration across subject areas, various forms of lesson planning, instructional methods and models, assessment principles and strategies, and tools for creating safe learning environments.

### **Qualifications:**

The successful applicant should have an M.Ed. or higher in an area relevant to the advertised course. A record of academic expertise in relevant theories related to the formation of teachers' professional identities is required. Current professional experience as a teacher and leader/administrator in schools is required. Relevant knowledge and experience of educational leadership in areas of classroom practice, leadership, administration and curriculum is required. Recent experience designing, teaching, and assessing a teacher education course at a university level is preferred. Successful recent experience working independently and as part of a team is essential. The B.Ed. is a provincially accredited program. Applicants will therefore be expected to teach to the accreditation standards for this course.

Applicants should include an up-to-date curriculum vitae, cover letter and evidence of recent successful teaching in schools or universities or other informal educational contexts (e.g., student evaluations); evidence of teaching or professional learning or research related to course content (e.g., course outlines, teaching materials, professional learning events, research outputs, etc.).
