**Course Title:** Ethics in Counselling Practice (EDUC 50D3 FA01)

**Course Description:** This course provides a critical analysis of professional, ethical, legal, and diversity issues related to practice, teaching, supervision, and research in counselling. Students are encouraged to explore personal beliefs and values, review ethics and legal documents, consider procedures for processing ethical inquiries and complaints, and engage in application of ethical decision-making processes.

Acadia University's Counselling Program is accredited with the Council on Accreditation of Counsellor Education Programs (CACEP) and meets the requirements for post-graduation national certification with CCPA and provincial registration with NSCCT. As such, all courses in the program have required core competencies that students must attain. Instructors are advised to consult with the Counselling Program Coordinator to identify the specific competencies relevant to the course they teach. A template is provided to instructors so that they may indicate competencies addressed in their course outlines.

### **Qualifications:**

The successful applicant must possess at minimum a Master's degree in the field (Counselling, Counselling Psychology, Social Work or related area), be registered/certified with a professional counselling body (Registered Counselling Therapist with the Nova Scotia College of Counselling Therapists, Certified Canadian Counsellor with the Canadian Counselling and Psychotherapy Association, Registered Social Worker, or Registered Psychologist with the Nova Scotia Board of Examiners in Psychology preferred), and have extensive and current professional experience relevant to the course content area.

Preference will be given to those applicants who meet one or more of the following criteria: bring diverse perspectives and identities to counsellor education, have engaged in scholarship in a related area, have formal academic training in counsellor supervision and/or possess a counsellor supervision credential (e.g., CCC-S).
